OFFICE ORDER

Sub: RULES AND REGULATIONS – Re-naming of Chennai Port Trust as Chennai Port Authority - Regarding.

-
- (1) The Ministry of Ports, Shipping and Waterways *vide* Gazette of India notification No. S.O. No. 4504 (E), dated 29.10.2021 had appointed 03.11.2021 as the date on which Major Port Authorities Act, 2021 had come into force. Accordingly, the MPA Act 2021 notification had been placed in the Board meeting held on 02.11.2021 and the Board *vide* **BR No. 100, dated 02.11.2021**, had taken note of the date of implementation of MPA Act 2021 with effect from 03.11.2021.
 - (2) Now, the **MOPS&W**, *vide* Gazette of India Notification No. **GSR 52 (E), dated 28.01.2022** has constituted the **Board of Major Port Authority of the Chennai Port**.
 - (3) The existing "Board of Trustees of the Port of Chennai" will be replaced by the newly constituted "**The Board of Major Port Authority of the Chennai Port**". As also the existing name of Chennai Port Trust will be changed to "**Chennai Port Authority**" Similarly, the abbreviation will be changed from "ChPT" to "**ChPA**".
 - (4) Heads of Departments are therefore requested to change the name of 'Chennai Port Trust' to '**Chennai Port Authority**' in all the name plates, common seal, seals (Stamps), letter heads, logo etc. wherever the name Chennai Port Trust appears. It is also requested to inform the **stakeholders** about the change in the name.
 - (5) This issues with the approval of the Chairman.

2. महापत्तन प्राधिकरण अधिनियम, 2021 के तहत गठित चेन्नई पत्तन का महापत्तन प्राधिकरण बोर्ड, एक शाश्वत उत्तराधिकार और सामान्य मुहर वाला एक स्थायी निकाय होगा जिसे, इस अधिनियम के उपबंधों के अधीन रहते हुए, चल और अचल दोनों ही प्रकार की संपत्ति का अर्जन, धारण और व्ययन करने की और संविदा करने की शक्ति होगी तथा उक्त नाम से वह वाद लाएगा और उस पर वाद लाया जाएगा। सदस्यों की नियुक्ति और उनका कार्यकाल अधिनियम में निर्दिष्ट या आधिकारिक क्षमता में पद धारण करने की अवधि, जो भी पहले हो, के अधीन होगा।

2. The Board of Major Port Authority for the Chennai Port constituted under Major Port Authorities Act, 2021 shall be a permanent body having perpetual succession and a common seal with power, subject to the provisions of this Act, to acquire, hold or dispose of property, both movable and immovable, and to contract, and shall, by the said name, sue or be sued. Appointment of members and their tenure will be subject to term as specified in the Act or holding of the post in official capacity, whichever is earlier.
