

Notice Inviting Tender through e-procurement mode

Online tenders through e-procurement mode are invited under Two cover system only from the GST registered contractors/firms who satisfy the eligibility criteria for the work of "TENDER FOR Chartering of 1No. 60 Ton Bollard Pull Ocean Going Tug and as Emergency Towing Vessel for a period of 5 years & further extendable for 1 year in Chennai Port Trust " as per details furnished hereunder.

Estimated Cost: Rs.46,62,38,058 /- (Excluding Applicable GST) EMD: Rs. 47,62,380/-

Completion period: five years

Minimum Qualification Criteria:

- (i) Average annual turnover during the last 3 years ending 31st March 2018 should be at least Rs.13,98,71,500/- (30% of the estimated cost); and
- (ii) Experience of having successfully completed similar works during the last 7 years ending 31st August 2018 as follows*:
 - a) **Three** similar completed works each costing not less than the amount equal to Rs. 18,64,95,200/- (40% of the estimated cost); (or)
 - b) **Two** similar completed works each costing not less than the amount equal to Rs. 23,31,19,000/- (50% of the estimated cost); (or)
 - c) **One** similar completed work costing not less than the amount equal to Rs.37,29,90,500 /- (80% of the estimated cost)

Note 1: - Similar works means chartering/hiring of tugs/ tug with ETA/offshore vessels/ships including its manning, technical operation and maintenance of vessels.

Note 2:- In case of bid submitted by JV, the Minimum Eligibility Criteria EXCEPT Financial Turnover can be fulfilled collectively by the Partners of the JV.

Note 3:- In the case of bid submitted by JV, the lead partner of the JV shall meet the Minimum Eligibility Criteria of Financial Turnover .

Documentary proof such as copy of work order / agreement and work completion certificate for the technical experience and audited balance sheet, Profit & Loss account statements for annual turn over certified by Chartered Accountant for meeting the eligibility criteria shall be submitted under Tender document - Technical bid link through e-procurement mode. **Note: The Tenderers shall enclose the copy of Work Order for similar works, successful completion certificates from clients indicating the date of completion, actual value of work done, work order reference number and date.**

The tenderer may submit either Notarized or Self attested copies of the documents. In case of self attested documents, the tenderer has to produce the original documents for verification before award of work. If the bidder has executed the work for private firms or as a sub- contract the TDS certificate for the particular year along with the above mentioned documents shall be submitted. The price bids of those firms who do not meet the eligibility criteria(Cover-I) will not be opened. All the documents as per Schedule – I to Schedule -XI shall be uploaded through e-procurement portal after scanning in pdf format in the Tender Document – Technical Bid.

GST registered tenderer /firms are only eligible to participating the tender. EMD should be paid in the form of Account payee Demand Draft/Fixed Deposit Receipt / Banker's Cheque or Bank guarantee from State Bank Of India and other Nationalized Bank pursuant to clause 16 of ITB of Technical Bid of the tender document, drawn in favour of "The Chairman, Chennai Port Trust" Payable at Chennai shall be uploaded with the tender document - Technical bid while submitting the tender electronically in the e- procurement Portal.

The original financial instrument towards EMD and originals of Integrity Pact and Power of attorney should reach the "Office of the Deputy Conservator, Chennai Port Trust" before opening of Technical Bid i.e. upto 1500 hrs on 18.01.2019 Non submission of EMD within the above period leads to disqualification of bids.
