Kindly arrange to start the work immediately in consultation with the Trust's Dy. Chief Engineer who will be the Chief Engineer's representative for this work and complete the same within **One week**.

The Security Deposit is exempted for this work and you start the work immediately after receipt of the work order.

You are requested to furnish a Declaration on Stamp paper of Rs. 20/- (non judicial) and forward the same immediately.

(a) The firm shall furnish the tax invoice as per GST Act / Rules in the name of Chennai Port Trust by mentioning the GSTIN of Ch.P.T and indicating amounts of GST separately. The GSTIN of Chennai Port is 33AAALC0025BIZ9.

(b) The firm shall remit the GST amount in the invoice to the Government within the due dates and also file the returns by mentioning the GSTIN of Ch.P.T to enable Ch.P.T to avail applicable input tax credit.

(c) Chennai Port Trust shall reimburse the GST component mentioned in the invoice to the Contractor / Supplier / Vendor only to the extent and on reflection of the same under the GSTIBN of Ch.P.T in the GST web portal.

Please arrange to furnish Bank A/C No, TNGST Registration Number, Service Tax Registration No., Area Code, Assessment circle and latest income Tax Clearance Certificate and PAN NO.

It may be noted that in addition to GST 1% of the billed amount will be recovered from the bill towards payment of CESS and remitted to TamilNadu Construction Workers Welfare Board (TNCWWB) as per the provisions of Tamil Nadu Manual Workers(Regulation of Employment and Conditions of Work) Act, 1982 and Tamil Nadu Manual Workers (Construction Workers) Welfare Schemes, 1994 and G.O (MS) no. 295 Dt: 17.12.2013 of labour and Employment(12) Department.
