This is in continuation of series of discussions & correspondences between CHPT and DCI for award of Maintenance Dredging of Entrance Channels, Dr. Ambedkar dock basin, Bharathi dock basin, Jawahar dock, Turning circle and all berths of Chennai Port on Nomination basis.

Based on the MoU signed between ChPT and DCI and terms and conditions of the contract agreement, including the dredging rates, mobilization / de-mobilization charges, duration etc, CHPT hereby issue the **Letter of Award (LoA)** to M/s. Dredging Corporation of India (DCI) for Maintenance Dredging at Chennai Port on Nomination basis for the value of Rs.24,26,92,000/- (Rupees twenty four crores twenty six lakhs and ninety two thousand only) excluding applicable GST.

Further, DCI is requested to submit the Performance Bank Guarantee of Rs.72,80,760/- and to enter into the Contract Agreement within 30 days from the date of issue of LoA by CHPT.

DCI shall mobilize dredger only from KPL to ChPT after completion of dredging work at KPL.

All other terms and conditions as stipulated in the contract agreement and MoPSW Dredging Guidelines for Major Ports 2021 will be applicable.
